Scope of Analysis:

As per letter of the SSP (Coordination) PSP, for Capital City Police Officer, Peshawar, KPK following was the scope of analysis:

- Opine whether the videos in USB are genuine or edited.
- Opine about the presence of these persons who appear in the videos available in USB or not.

Summary of Analysis:

The evidence item was write blocked using Digital Intelligence Tableau T356789iu Forensic Bridge write blocker and its working copy was prepared and preserved for future testing. Hash verification was done using md5summer version 1.2.0.11. The examination was performed on working copy as per Procedure Manual using frame-by-frame analysis. All the analysis was performed only on the visual contents of working copy of the evidence.

- Following sixteen (16) video files were found in USB (Item # 1).





- After forensic video analysis, no editing features were observed in the visual contents of above-mentioned video files from Sr. # 1 to Sr. # 8 contained in Item # 1.
- After forensic video analysis, no editing features were observed in the visual contents of above-mentioned video files at Sr. # 9 contained in Item # 1, except joining of frames at a single point.
- After forensic video analysis, no editing features were observed in the visual contents of above-mentioned video files from Sr. # 10 to Sr. # 12 contained in Item # 1, except addition of logo/text.
- After forensic video analysis, no editing features were observed in the visual contents of above-mentioned video files at Sr. # 13 and Sr. # 14 contained in Item # 1, except addition of logo/text and joining of frames at multiple points.
- After forensic video analysis, editing features of joining and merging of multiple video clips of different camera views were observed in the visual contents of above-mentioned video files at Sr. # 15 and Sr. # 16 contained in Item # 1.
- After forensic analysis, it was concluded that the facial features of the person "Amir Khan Chamkani" seen in profile picture were found to be **Matched** with the facial features of the suspected person seen in video(s) contained in Item # 1.
