




**ELECTION COMMISSION OF PAKISTAN**  
**NOTIFICATION**

**No.F.17(2)/2026-Coord-M/F-** Pursuant to the Order dated 7<sup>th</sup> March, 2026 passed by the Special Court Anti-Terrorism No.1, Rawalpindi, Division Rawalpindi, in case titled "State Vs Asim Rehman etc, Application under section 19(10) ATA, 1997, FIR No.708/23, P.S RA Bazar, Rawalpindi", whereby Mr. Murad Saeed, has been awarded sentence to imprisonment for a period of ten (10) years and decision taken thereon by the Commission on 25<sup>th</sup> March, 2026, Mr. Murad Saeed notified as returned candidate on a general seat of Senate from Khyber Pakhtunkhwa Province, vide ECP Notification No.F.3(4)/2024-Coord.Vol-I dated 24<sup>th</sup> July 2025, has become disqualified under Article 63(1)(h) of the Constitution of Islamic Republic of Pakistan and is hereby de-notified. Resultantly, his seat has become vacant.


